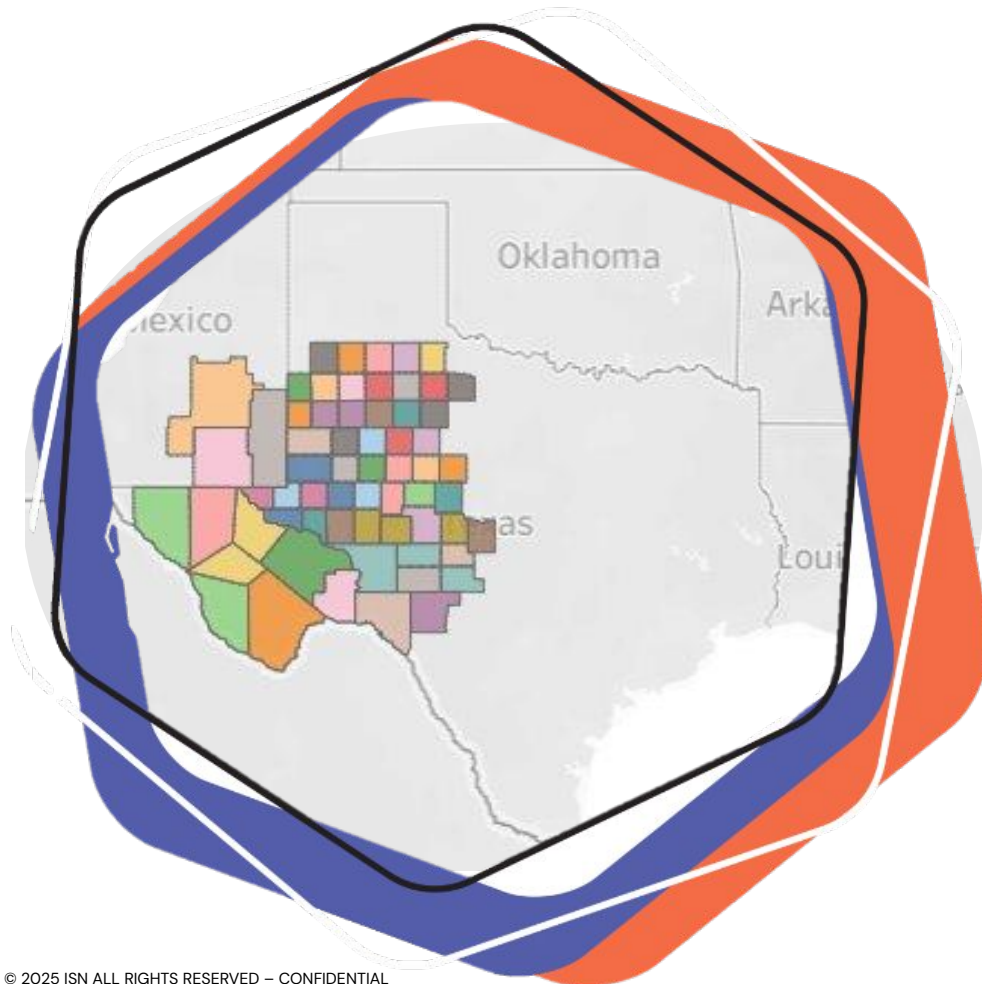

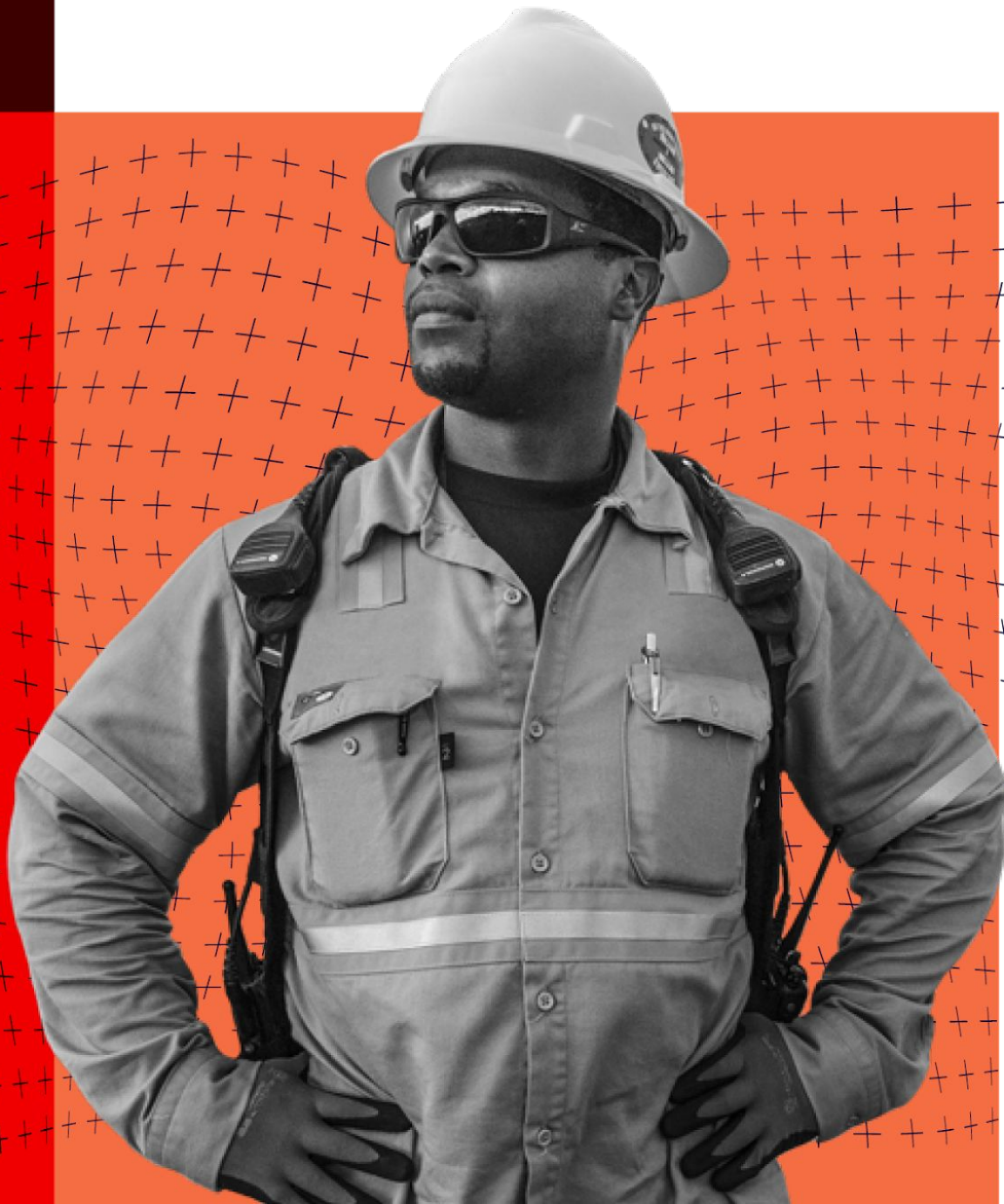

Analyzing the Data - SIFs

What is a SIF?



Definition of a SIF: Any work-related fatality, in-patient hospitalization, amputation, or loss of an eye.



ISN OSHA Log Analysis

- ISN extracted incident information from contractors who reported a SIF in the Questionnaire (2017 – 2024)
- Applied analytics and machine learning models to classify these incidents, potentially identifying SIFs and **generating additional insights**

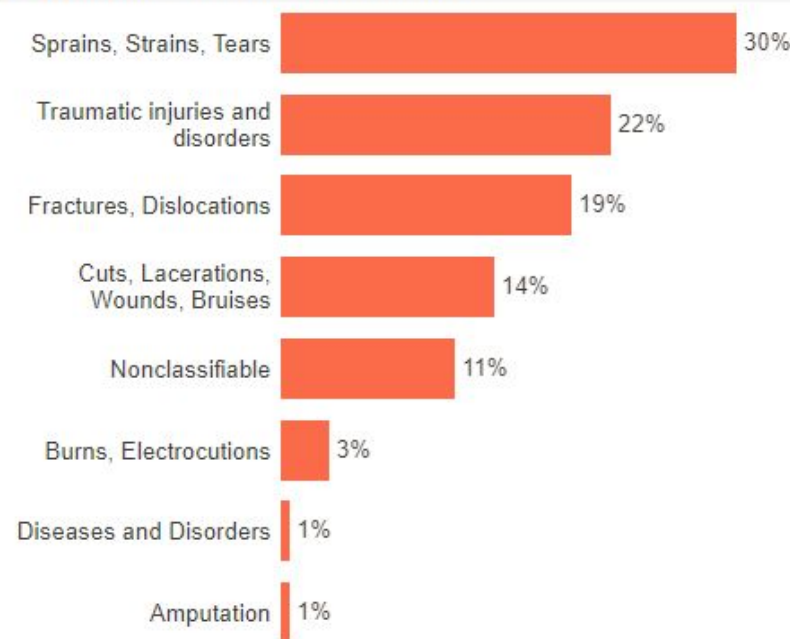

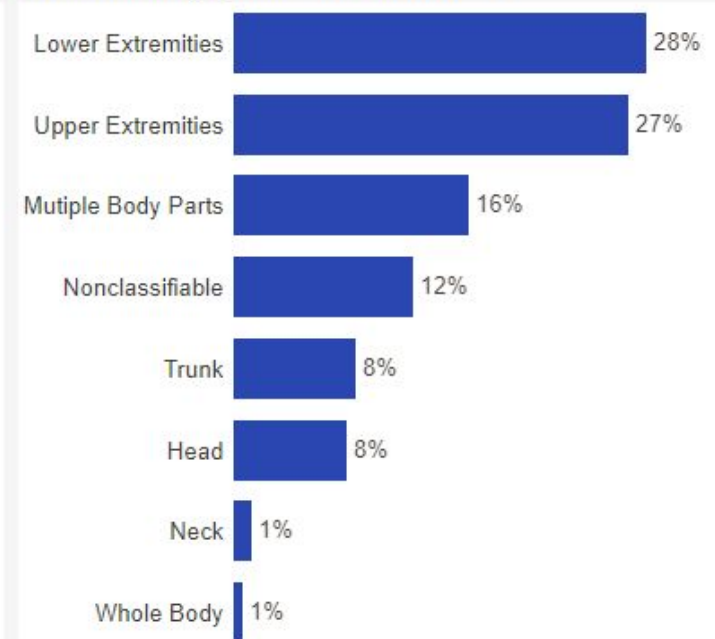

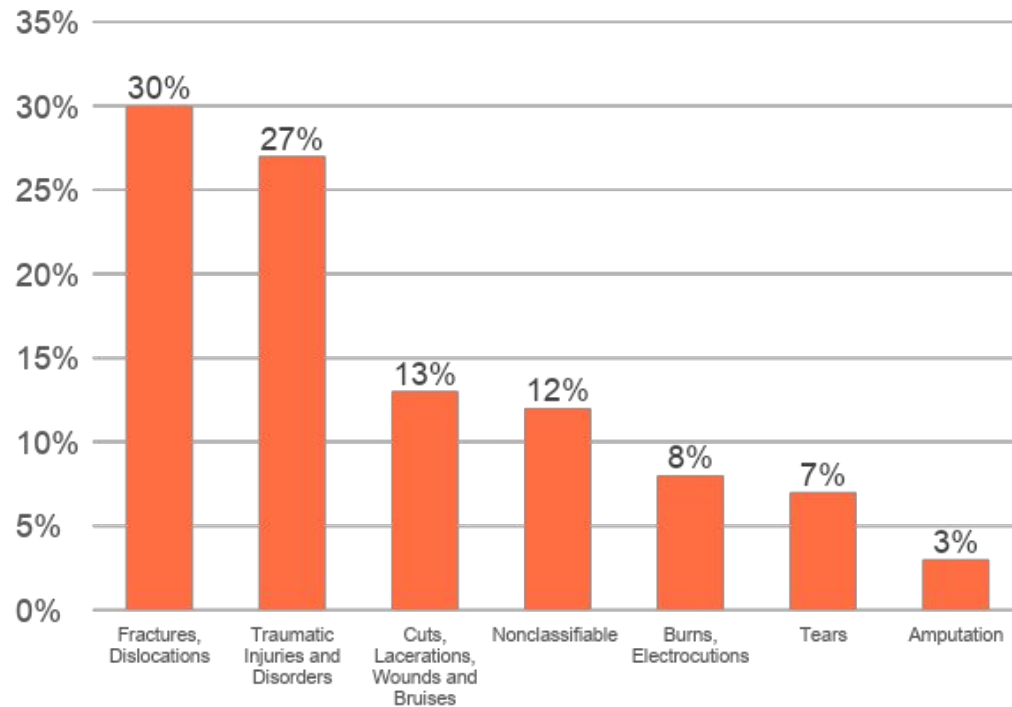

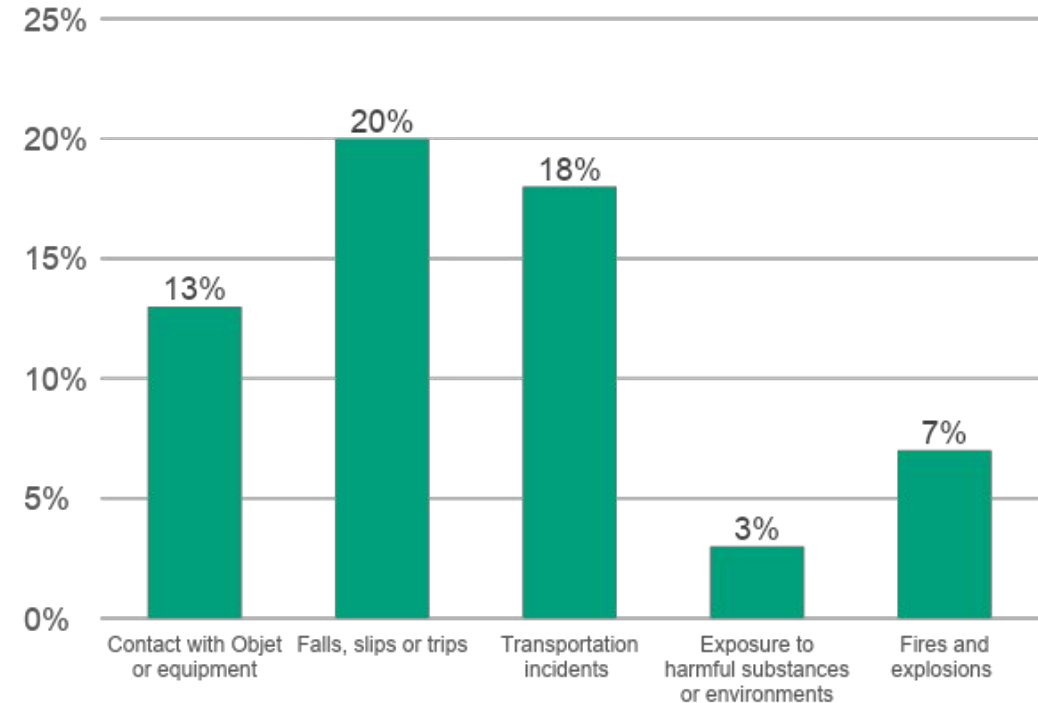

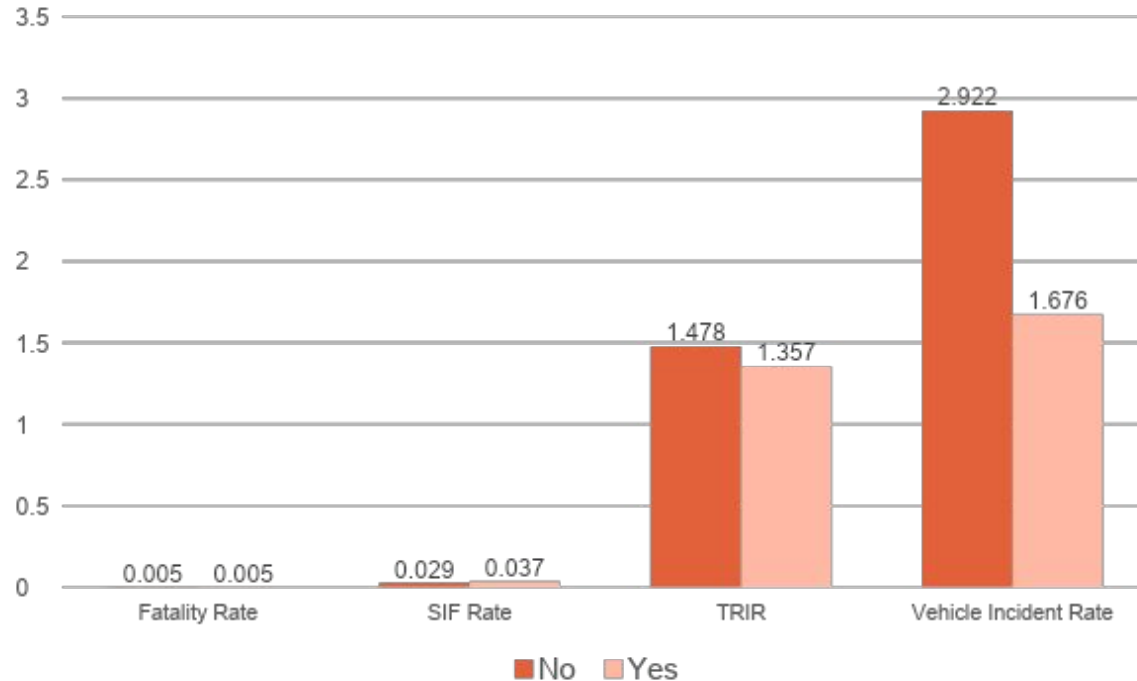

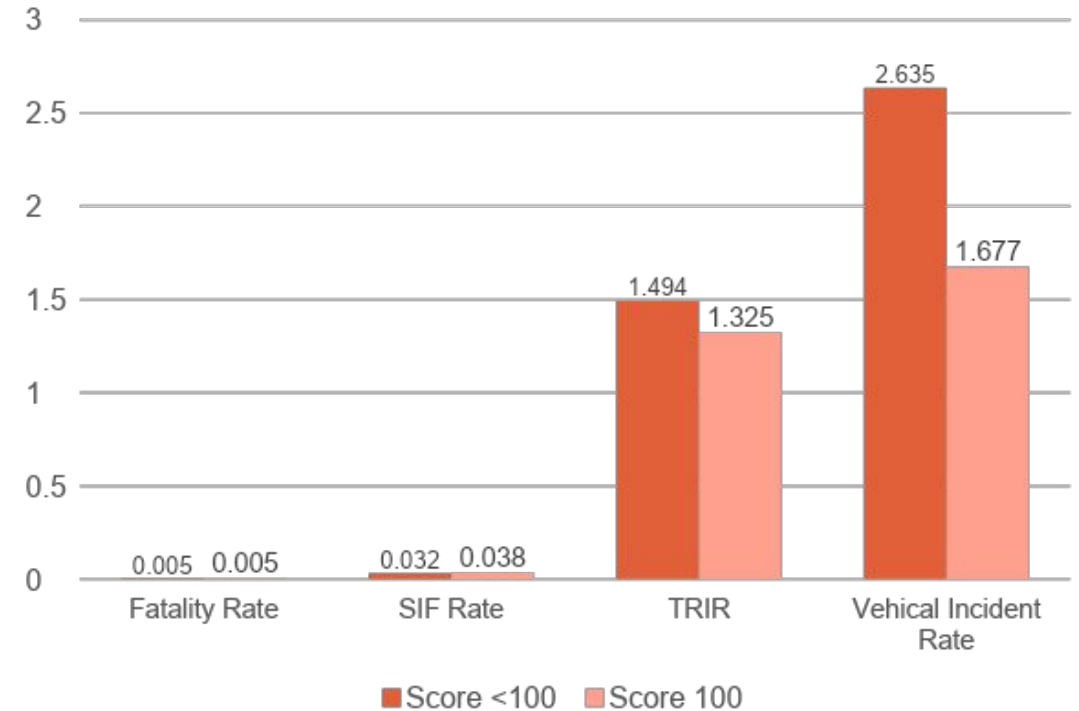
Transportation Safety Statistics Analysis

Transportation Written Program vs Safety Statistics



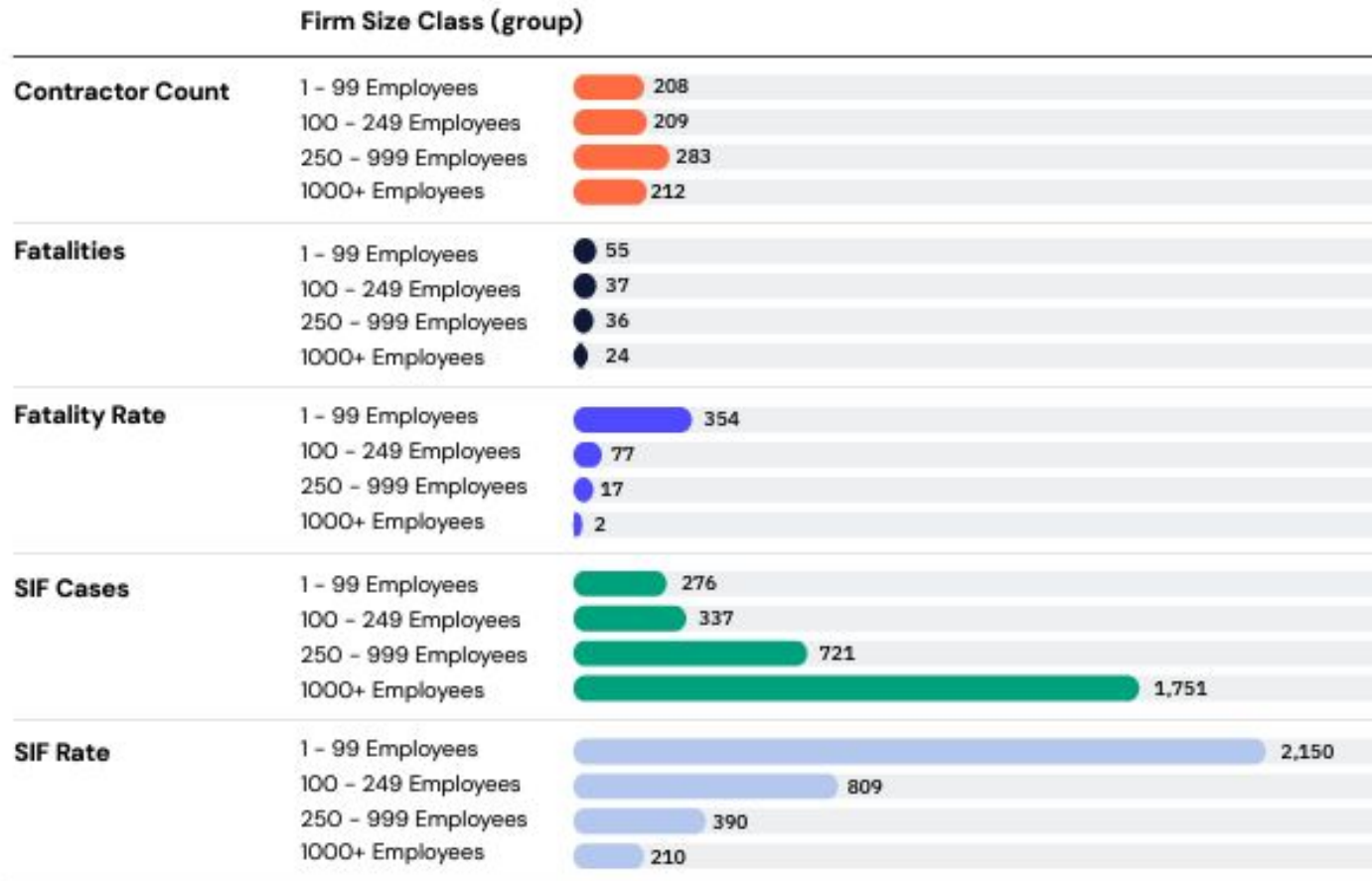
Contractors with Transportation Written programs have a **43% lower** Vehicle Incident Rate than those who do not have programs.

Driving Program Score vs Safety Statistics



Drivers with a driving score less than 100 have a **41% higher** Vehicle Incident Rate

Key Statistics by Company Size



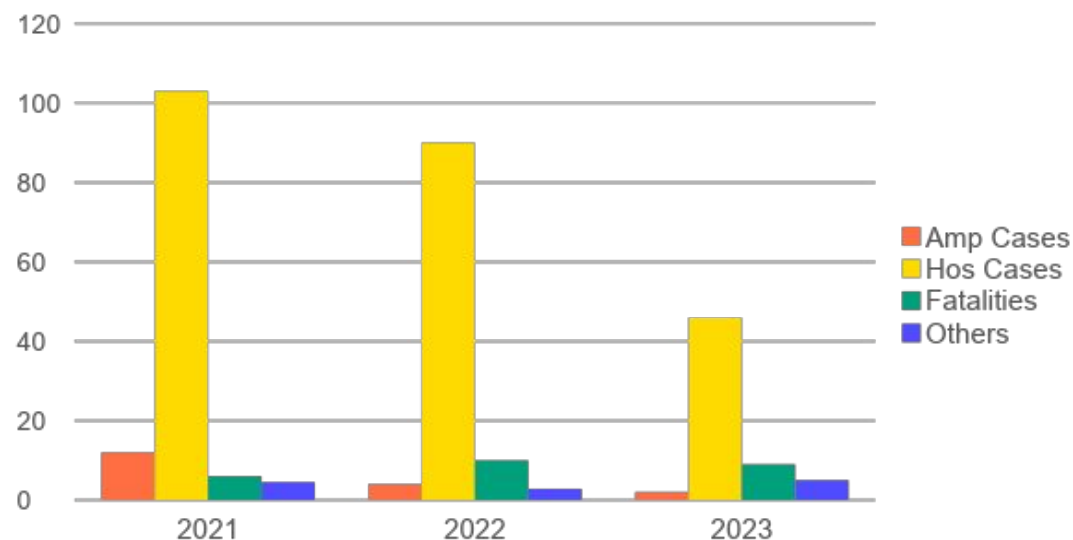
- The group with the highest rate of fatalities is not correlated with the largest company size, but rather mid-size companies.
- Much like TRIR, smaller companies see the biggest impact in their overall SIF rate for each SIF event
- Regardless of company size, SIF's have a significant impact on both the affected individual and the organization.

Oil & Gas Industry Breakdown: Three-Year Lookback

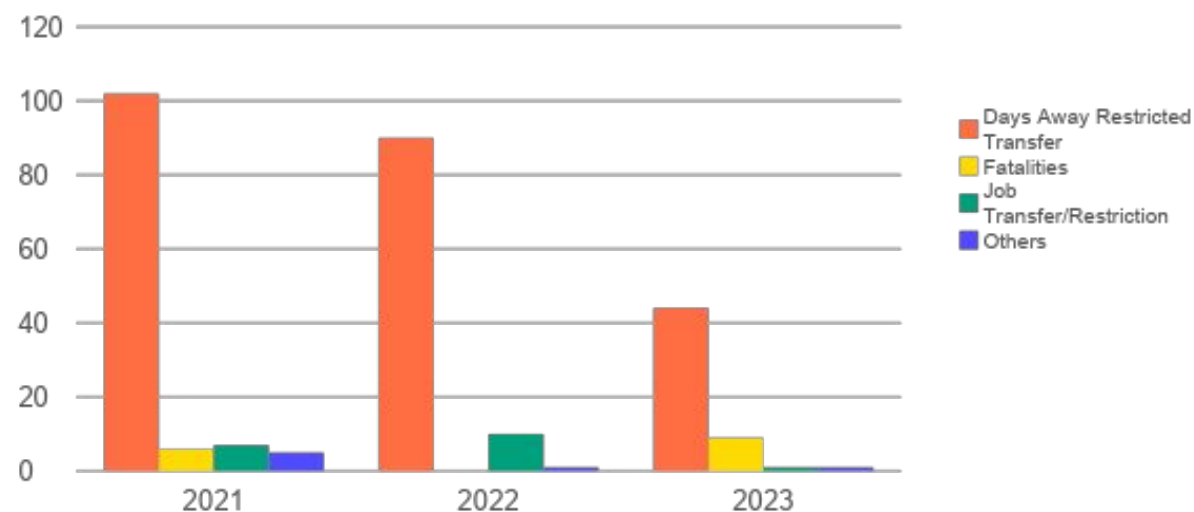
2021 – 2023 Data

- Drivers reported the most incidents all three years
 - Laborer and mechanic were second and third most reported job titled
- Highest number of incidents occurred on Wednesdays and Thursdays
- February and November were the months with the highest number of incidents

- FMCSA Data is used to calculate CSA – BASIC* scores and statuses

Hiring Client Spotlight: Plains



A critical part of Plains' operations is its partnership with, and safety of its carriers. As of July 2021, Plains increased its visibility and requirements by tracking carrier data through ISNetworld.

Plains prioritizes verified data points from the FMCSA including carrier Census, Crash, Inspection and Violation data (similar to the Canadian Carrier Profile). The components are used to calculate a score which helps Plains prioritize working relationships with safer carriers.

In addition to the data points available in ISNetworld from the FMCSA, Plains factors the below requirements into its carrier management process to mitigate risk:

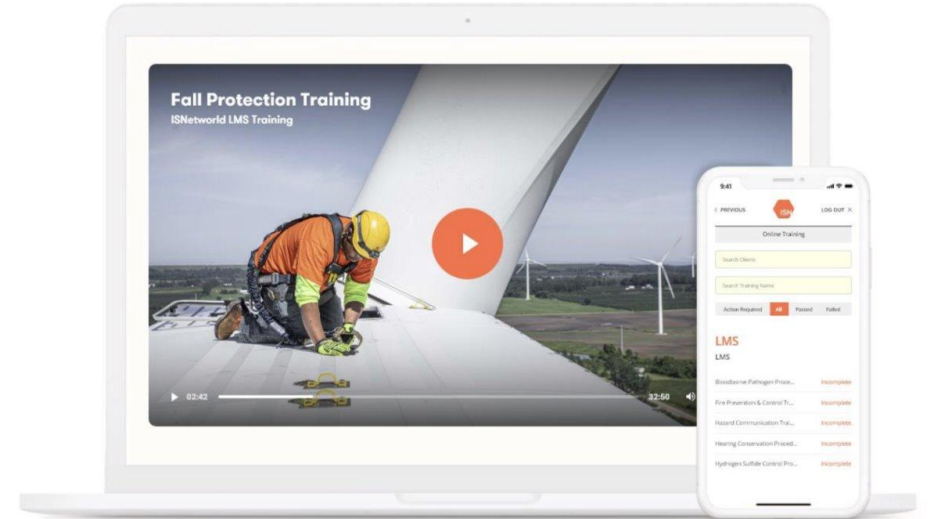
